Initial Random Selection: Batch numbered tickets 1-387 representing 387 Ballot Marking Device (BMD) ballots and batch numbered tickets 1-2,060 representing 2,060 Declared Vote By Mail (VBM) batches for the **September 14, 2021 California Gubernatorial Recall Election** were placed inside a rotating drum, and batches were randomly drawn by Elections Official representatives. The initial random selection consisted of four (4) BMD and twenty-one (21) VBM batch numbers.

Contest Type: Single winner (Vote for one candidate or Yes or No for measure); and multi-winners (Vote for more than one)
